## A cheerleader fight back - Kaitlyn Collins

On these pages, they share photos, stories and jokes about the games and the players. Of course, they sometimes make negative comments about other teams and players too! The name of the Green Bay Packers cheerleader in the photo was Kaitlyn Collins. She found her photo on the Chicago Bears' Facebook page, read the comments and was very upset. She complained to Facebook, but they did not remove the photo. They said that it was not cyberbullying, according to their rules. So Kaitlyn decided to fight against the bullies in her own way. She made a video and posted it on YouTube.

In her video, she did not speak; she wrote messages on paper and showed them to the camera. She explained that most of the Facebook comments were 'too horrible to repeat' but they had the same theme: they said she was 'ugly'. She also explained that some comments were different - they were kind. One comment said: 'I'm a Bears fan, but she is not ugly - and she is also somebody's daughter.' Her video became a viral story. Soon, it had nearly a million views on YouTube.

After that, somebody from the Chicago Bears fan club deleted the photo from its Facebook page. In its place is a message about the dangers of cyberbullying. And now Kaitlyn has her own channel on YouTube. Her videos continue the fight against cyberbullying.
